Nursing Home Developments

As we know, Nursing Home Residents have disproportionately been affected by COVID-19 with nursing home residents representing 43% of all COVID-19 deaths but representing less than 1% of the U.S. population.

days of lockdown for nursing home residents.

CMS and CDC Join Together to Offer Virtual Infection Control and Prevention Training

In response to current and past years of findings that nursing homes were not prepared to prevent or control infections, a virtual training is now available. As a result of the findings and knowing that most nursing home staff have not been trained to control or prevent infections, CMS and CDC are providing extensive training for nursing home staff with an added financial incentive that covers the staff training time.

There are two tracks available to nursing home staff - a basic training track and an advanced training track in infection control and prevention.

According to CMS, "The infection prevention and control course is covered in 23 modules and sub-modules, estimated at 19 hours to complete. It includes:

- User-friendly, informative and educational course content;
- Helpful resources (e.g., training tools, checklists, signs, and policy & procedure templates);
- Modules that can be completed at any time, in any order, and over multiple sessions, depending on the learner's schedule; and
- Continuing education credits and a certificate of completion are available for those who complete all modules and pass a post-course exam."

The **training courses** are available free of charge.

CMS Issues New Surveyor Guidance for COVID-19 and Nursing Home COVID-19 Testing

In an effort to address and standardize testing protocols, CMS has issued guidance to the State Survey Agency Directors. Additionally, there are additional components that have been added into the survey review process including assessment of the mental health of residents; communication with residents, families, and caregivers; and antipsychotic medication for dementia residents. Information available in the CMS memo of August 26 to State Survey Agency Directors.

On September 8, CMS The Department of Health and Human Services announced they will be sending nursing homes 750,000 COVID-19 point-of-care tests that can be administered quicker and simpler than other options. Next week, the Abbott BinaxNOW COVID-19 Ag Card tests are in addition to previously announced shipments of devices and test materials. The tests use a nasal swab placed on testing material that will detect the coronavirus and do not require a separate reader and are applicable to residents and staff in their first seven days of being ill with COVID-19. Initial distribution will go to the recently CMS designated nursing homes in counties coded red or yellow, which means they need the most frequent staff testing under new rules.

CMS added a new federal compliance citation for lack of reporting of data to the National Health Safety Network and also made changes to the COVID-19 survey documents including protocols,

worksheets, and other documents.

For those not familiar with the surveillance approach, nursing homes can be cited for non-compliance and some citations require special tags associated with the level and extent of harm to nursing home residents. These special Substandard Quality of Care compliance with levels of harm include:

"Why Black Aging Matters, Too"

<u>Kaiser Health News</u> just released the results from analysis of older adult deaths that aligns with the general findings within the U.S. population on COVID-19 deaths - Black seniors are disproportionately effected by COVID-19.

According to Kaiser Health News, "A KHN analysis of <u>data from the Centers for Disease Control and Prevention</u> underscores the extent of their vulnerability. It found that African Americans ages 65 to 74 died of COVID-19 five times as often as whites. In the 75-to-84 group, the death rate for Blacks was 3½ times greater. Among those 85 and older, Blacks died twice as often. In all three age groups, death rates for Hispanics were higher than for whites but lower than for Blacks."

New Care Compare Web Site

CMS recently released the Care Compare web site that combines all eight siloed public reporting systems into one web site. The <u>Care Compare web site</u> is up and running. Project Patient Care will be making avialable recorded tutorials in early October on how to access the information from a patient, family, and caregiver perspectives.

In a <u>new video</u>, Dr. Bakris shares with Project Patient Care the importance of continued care and how he is moving ahead, without fear, with his own surgery in the midst of COVID-19.

Project Patient Care worked with patients, families, and caregivers to prepare a guide for them to use in

discussions with their care providers so they, too, can seek care without fear. <u>The Guide</u> was highlighted in NY Times, KHN, and other media. As with all of our material, the video and guide are available to all at no charge.

We continue to have a busy time at PPC as we respond to many requests to share the voice of the patient, family, and caregiver with providers, health organizations, and private and public entities.

During this past month we have produced several recorded webinars and have participated in several National Meetings, including Pat Merryweather-Arges at Academy Health Annual Research Meeting on public data and data privacy issues. During August and September we have been busy speaking at the National Association of Health Data Organizations (Pat co-chaired annual meeting); National Patient Safety Movement Foundation World Patient Safety Day (Marty Hatlie) is on Committee; Focus on Disparities with National Patient Safety Movement Foundation (Pat presented on live webinar); and National Association for Healthcare Quality (Pat and Marty are on panels focused on World Patient Safety Day).

The New York Times featured an article on June 30 on Project Patient Care's Guide, "Recommendations for and by Patients, Families, and Caregivers for Elective Surgeries and Invasive Procedures During COVID-19 Pandemic" . Reporter Judith Graham of Kaiser Health News, highlighted the concerns and expectations patients have in returning for healthcare services and the issues that healthcare providers need to address for patients
