- Release of a List on All Nursing Home Special Focus Facilities
- Several CMS Technical Expert Panels Seeking Patients and Consumers

Robinson, Ph.D.. Both Phenom and Marcus are having a positive impact on youth and young adults as they spread peacebuidling initiatives and skills throughout Chicago with a focus on the communities that have experiencd the highest incidence of violence now and in the past.

**Teh Ray 'Phenom' Hale, Sr.** has dedicated his life to bringing

peace building and restorative justice programs to youth through his artistic talent. As a well known and celebrated hip-hop artist, Phenom has performed scross the US and abroad. Phenom started POETREE and also L.Y.R.I.C (Let Your Rhymes Inspire Creativilty). The L.Y.R.I.C. program serves Chicago-based high school students and offers them opportunity to write and perform poetry as a non-violent means to stopping the violence in their neighborhoods. As a main member of HIP-HOP DETOXX, PHENOM has also hosted major events such as Ritual Sundays, Neo Soul Explosion, and Lyricist Loft, and while doing so this incredible artist has mentored over 6500 plus youth throughout the US. His goal is to inspire change in the urban neighborhoods of Chicago and abroad.

Phenom started the EmceeSkool with a vision to develop young artists in to community organizers and youth ambassadors for peace and as a mission to provide self-motivated artists with the proper tools and training to deliver highly impactful projects that can be used as peace making and humanity building strategies worldwide. The objective of *EmceeSkool* is to 'develop a social-creative-arts initiative designed to strengthen young teaching artists in the fundamentals of becoming a sustainable and impactful asset to their community and family via organizing through the arts. This will serve as a restorative justice and violence prevention strategy.'

**Marcus Robinson, Ph.D.**, is the Managing Director of Collaboraction, a theater arts program with a vision "to incite empathy, thought, dialogue and action through original devised theatre and live experiences made in collaboration with our audience and cultivating measurable change in attitude and behavior." Collaboraction has a goal to increase their impact around Chicago's most critical social issues, including racism and violence.

Marcus has lead organizations in several communities and is a transformational leader of non-profit management, talent development, corporate culture, and diversity with inclusion. His extensive education compliments his years of experience as president and CEO of multiple corporations, including the Consortium of Community Development, Citizens for Progressive Change, Inc. and wetWare Inc. He also was founder and principal consultant of his own firm, Social Innovation Group, which worked with clients to create inclusive cultures that drive sustainable high performance.

Marcus has served as a hospital board member in Michigan and currently serves on a Patient and Family Advisory Council (PFAC) of a Chicago safety-net hospital in Englewood. Marcus has a 'passion for helping families and youth living in low resource communities, and he firmly believes that with Collaboraction by his side, sustainable change is possible.'

### CHRONIC KIDNEY AND END STAGE RENAL DISEASE

On July 10, Department of Health and Human Services Secretary Alex Azar announced a series of sweeping proposals to transform Chronic Kidney Diesase (CKD) and End Stage Renal Disease (ESRD).

The changes include:

- Early Detection of CKD with additional attention to patients with diabetes or hypertension
- Interventions early on to try and delay CKD patients advancing to Stage 5 CKD
- Support to dramatically increase dialysis at home
- Increasing live kidney transplants though proactive outreach and measurable results along with supportive services for the live donors
- Addressing the cost of post transplant medications
- Payment models to drive improvements in detection, management, and health outcomes

The National Kidney Foundation (NKF) estimates that 30,000,000 people in the U.S. have chrronic kidney disease and most do not know they have CKD. Often times referred to as a silent disease, CKD symptoms do not appear until Stage 3. There are tests that can detect CKD in every person; however, very few patients understand or receive the results.

In addition to the challenges of being on dialysis, it is also a costly disease with approximately 7% to 8% of the Medicare budget going for treatment of patients with CKD. The National Kidney Foundation estimates that 726,000 people have irrreversible kidney failure or ESRD. Of the 726,000 patients, over 100,000 ESRD patients are on the kidney transplant list awaiting a kidney donation.

President Trump signed an Executive Order directing federal agencies to educate and treat people with early forms of kidney disease, to make kidney transplants easier to get, and to shift the financial incentives for clinics and doctors away from the existing system that relies heavily on dialysis.

At the announcement in Washington, D.C. on July 10, two of the PPC Champion Change Agents from Mach 2019, Mary Baliker and Bobbie Reed, were at the meeting wih Secretary Azar. Our third Champion of Change Agent, Precious McCowan was not able to attend as she was recovering from her recent kidney transplant.

Champion Change Agents

Proposed rules on hospital cost trransparency were rercenlty released in response to the June 24 Executive Order on Improving Price and Quality Transparency in American Healthcare to Put Patients First.

**Cost.** The proposed cost transparency rules were embedded in the Hospital Outpatient Prospective Payment System Proposed Rule with comments due to CMS by September 27, 2019. The proposed cost transapency rule includes:

Hospitals would need to make public their standard charges – both 'gross charges' such as those in a chargemaster, and 'payer-negotiated rates' – in two ways:

- 1. A comprehensive, machine-readable file that makes public all standard charge information for all hospital items and services, and
- 2. A consumer-friendly display of common "shoppable" services derived from the machine-readable file. CMS is requiring that these charges be made public and updated at least once annually.

CMS seeks comment on technologies or standards that could facilitate public access to real-time updates to make this information readily available to consumers by applications – such as through an open Application Programing Interface (API).

*Quality*. Within the June 24 Executive Order there were several directives on quality, including:

- Streamlining the numerous different measurements the federal government uses to track healthcare quality
- Reviewing a number of HHS quality programs that were initially developed nearly
  20 years ago to strengthen organizational capacity to improve outcomes for
  beneficiaries. These quality programs administered by the Centers for Medicare &
  Medicaid Services (CMS), Agency for Healthcare Research and Quality (AHRQ),
  Centers for Disease Control (CDC), Health Resources and Services Administration
  (HRSA) and Indian Health Service (IHS), have not undergone a systematic objective
  review to ensure they are serving their stated purpose of improving processes and
  enhancing communication to improve beneficiary outcomes.

Additionally, a Quality Summit is being orrganized that will bring together key industry stakeholders and government leaders to discuss how current quality programs administered by HHS can be further evaluated, adapted, and streamlined to deliver better outcomes for American patients. The Quality Summit will be chaired by Deputy Secretary Eric Hargan and Peter Pronovost, M.D., Ph.D., a renowned international expert on healthcare quality and patient safety.

Project Patient Care has been writing about the critical importance of health care costs to consumers including hospital, ambulatory, and surprise bills. The February 2019 PPC Newsletter had a deeper dive into the cost issues.

### NURSING HOME SPECIAL FOCUS FACILITIES

As the result of some Senate inquiries into a 'non-public list', another 400 special focus facilities were identified in addition to the current public list of approximately 88 special focus facilities. To view the entire list of Nursing Home Special Focus Facilities - click Here

According to CMS, Nursing Home Special Focus Facilities have:

- More problems than other nursing homes (about twice the average number of deficiencies),
- More serious problems than most other nursing homes (including harm or injury experienced by residents), and
- A pattern of serious problems that has persisted over a long period of time (as measured over the three years before the date the nursing home was first put on the SFF list).

Per CMS, "Although such nursing homes may periodically institute enough improvements to correct problems identified on one inspection, significant problems would often resurface by the time of the next inspection. Such facilities with a "yo-yo" or "in and out" compliance history rarely address underlying systemic problems that give rise to repeated cycles of serious deficiencies, which pose risks to residents' health and safety. To address this problem CMS created the "Special Focus Facility" (SFF) program."

- Focus Group for Hospice Patient Assessment Instrument Deadline August 26, 2019
- Behavioral Health Measures: Development, Reevaluation, & Maintenance -September 27, 2019
- Hospital Quality Star Ratings on Hospital Compare Deadline August 19, 2019
